As technology improves, newer imaging modalities are being deployed to diagnose a wide array of conditions. Even so, many imaging tests are not needed and may account for up to \$12 billion each year in unnecessary health cost spend.¹

Payers and providers need evidence-based clinical tools to help them make informed decisions regarding the appropriateness of high-cost imaging. InterQual Imaging Criteria is backed by the best clinical evidence available to help support decisions regarding imaging tests.

Q&A Format—Allows for an intuitive end-user experience and enables easier training.

Comprehensive Imaging Criteria—Covers more than 200 unique imaging tests organized into more than 30 test families, and includes the majority of adult indications and select pediatric and adolescent indications, where appropriate.

Test Sequence Recommendations—Helps ensure that the appropriate sequencing of tests is considered prior to the approval of advanced imaging, to help eliminate patient exposure to unnecessary tests.

Alternative Imaging Recommendations—Identifies situations in which alternative imaging studies may be appropriate based on medical evidence and the specific clinical scenario.

Limited Evidence Recommendations—Prompts users to collect information to assist a physician reviewer in conducting a secondary review. These recommendations apply to imaging studies in which the evidence does not fully support the test given the specific clinical scenario.

Streamlined Review Process—Identifies urgent conditions and indications to alert the user that prior authorization is not required and that a review can be done retrospectively.
