Support Appropriate Acute Care for Pediatric Patients

InterQual® Acute Pediatric Criteria helps payers and providers support effective, efficient care management for pediatric patients. The criteria are organized by primary condition and include relevant complications and comorbidities within one view. By addressing the patient as an individual case, rather than taking a one-dimensional approach, the criteria facilitate the movement of patients through the care continuum. This integrated approach to utilization and case management is a powerful aide to decrease inappropriate admissions, avoidable days, and readmissions.

Inclusion of Comorbid Conditions—Support appropriate admission of medically complex patients with comorbid conditions who might not meet criteria for the primary condition alone, minimizing the administrative inefficiency of secondary reviews for those who qualify for inpatient care. The criteria include consideration of comorbid conditions for both admission and continued stay.

Responder Criteria—Help adjust patient care timeframes and incorporate clinical stability criteria relevant to the patient's condition, complications, or comorbidities to support determination of discharge readiness or a continued stay. Discharge Screens and the Transition Plan tool support conditions of participation (COP) requirements for discharge planning.

Utilization Benchmarks—Help guide patient placement and assist discharge planning. Benchmarks include proprietary InterQual Percent Paid as Observation and InterQual Length of Stay benchmarks, which are based on claims data from millions of patient discharges.

Proactive Care Management Guidance—Provides content, including expected progress and care facilitation, to facilitate a conversation between care managers and the care team. Content is designed to ensure that the patient is progressing along the expected trajectory and any barriers are addressed.

Nine Levels of Care—Includes the full range of pediatric levels of care: Observation, Acute, Intermediate, Critical, Newborn Nursery I, Special Care Nursery Level II, Neonatal Intensive Care Nursery III, Neonatal Intensive Care Level IV, and Transitional Care.
