Clinical integrity

The clinical criteria populating each module are updated at least once annually and are produced through a rigorous process grounded in the principles of evidence-based medicine. Criteria development is conducted by a clinical team that includes physicians, registered nurses and allied health professionals. The team relies on systematic, critical appraisal of the medical literature using elements of the Grading of Recommendations, Assessment, Development and Evaluation (GRADE) approach. Draft criteria are subjected to systematic scrutiny by our InterQual Clinical Review Panel of more than 1,100 independent, multidisciplinary experts.

Level of Care



InterQual Level of Care Criteria provide health care organizations with the ability to prospectively, concurrently and retrospectively assess clinical appropriateness. Robust clinical detail allows organizations to evaluate severity of illness, comorbidities and complications, as well as the intensity of services being delivered, to determine the most suitable and safest level of care. The criteria also assist in discharge planning and care transitioning across the continuum. Medicare policy notes and a direct link to the Medicare Benefit Policy Manual provide additional information within the medical review workflow to support policy alignment.

Acute Adult	The Acute Adult module helps clinicians evaluate the appropriateness of admission, continued stay and discharge of acute care patients age 18 and older. Criteria are organized by primary condition presented in a single view that incorporates relevant complications, comorbidities, guideline-standard treatments, proactive care management guidance and length-of-stay benchmarks. By addressing the complete needs of each patient, the criteria facilitate movement of patients through the care continuum based on their condition and response to treatment. This integrated, holistic approach provides a powerful mechanism for decreasing inappropriate admissions, avoidable days and readmissions.
Acute Pediatric	The Acute Pediatric module helps clinicians determine the appropriateness of admission, continued stay and discharge at acute care facilities for patients under 18 years of age. The module features the same condition-specific format as the adult criteria.
Long-Term Acute Care	The Long-Term Acute Care module helps clinicians determine the appropriateness of admission, continued stay and discharge for long-term acute care patients. This module includes responder and partial responder criteria to help clinicians adjust patient care time frames and interventions based on outcomes. It also offers guidance around discharge and transition planning for patients who no longer require skilled care or whose care can be safely managed in an outpatient setting or at a lower level of care.
Inpatient Rehabilitation	The Inpatient Rehabilitation module helps clinicians determine appropriateness of admission, continued stay and discharge at inpatient rehabilitation facilities for adult and pediatric populations. The module includes methods for addressing complications and setbacks associated with the onset of medical instability in a timely and medically appropriate way.
Subacute and Skilled Nursing	The Subacute and Skilled Nursing module helps clinicians identify medical necessity and the most suitable level and complexity of care based on clinical need and stability. Guidance also is provided for discharge and transition planning. Clinical evidence supports the appropriateness of skilled treatments and services to support optimal care and to help organizations withstand audit scrutiny.
Home Care	The Home Care module streamlines care management for patients who require services in the home setting. The criteria help determine the appropriateness of the initial review and ongoing service needs, visit recommendations, and discharge. The criteria address both adult and pediatric patients and include intermittent, skilled home care services, private-duty nursing, hospice and palliative care needs.
Outpatient Rehabilitation and Chiropractic	The Outpatient Rehabilitation and Chiropractic module illuminates the most suitable level and complexity of rehabilitation and chiropractic care in addition to maintenance therapy and habilitation. The criteria help clinicians screen for the initial authorization and ongoing care needs and also provide guidance around discharge and transition planning to help avoid costly readmissions. Coordination in the outpatient rehab and chiropractic setting can help improve outcomes, minimize costs and ensure timely transitions to appropriate levels of care.

Behavioral Health



InterQual Behavioral Health Criteria are specifically developed to help payers and providers optimize behavioral health care decisions. Much of the criteria are organized in our continuum format, which presents all settings of care in one view and incorporates the episode-day/episode-week feature to provide timeline guidance for each patient and condition. Medicare policy notes and a direct link to the Medicare Benefit Policy Manual provide additional information within the medical review workflow to support policy alignment.

Adult and Geriatric Psychiatry

The Adult and Geriatric Psychiatry module supports initial and continued stay decisions across the behavioral health continuum for patients or members age 18 and older. The criteria allow care managers to consider symptoms, functional status, the quality of support systems and safety as determinants for the most appropriate setting of care.

Child and Adolescent Psychiatry

Designed for patients ages 4 through 17, the Child and Adolescent Psychiatry module helps care managers optimize initial and continued-stay level of care behavioral health decisions. The module's continuum format lets clinicians address multiple symptoms simultaneously to provide a comprehensive picture of the patient's condition.

Substance Use Disorders

The Substance Use Disorders module helps clinicians plan and deliver appropriate substance use care for patients and members age 12 and older. The criteria allow for greater transparency and alignment among stakeholders within and across organizations.

Behavioral Health Services

The Behavioral Health Services module supports medical necessity determinations and documentation for behavioral health procedures, including applied behavioral analysis, psychological testing, electroconvulsive therapy, neuropsychological testing and vagus nerve stimulation, as well as other medications, tests, programs and procedures. The module is aligned with our Ambulatory Care Planning Criteria and is presented in the same QandA format.

Ambulatory Care Planning



InterQual Ambulatory Care Planning Criteria feature extensive informational notes and references that support clinical recommendations and provide guidance to the reviewer. The suite's intuitive QandA format supports efficient review workflows. When appropriate, evidence-based recommendations are suggested based on the clinical scenario presented.

Procedures

The Procedures module covers more than 500 high-volume, high-cost procedures and includes all major body-system categories for both adults and children. Utilizing a proprietary setting benchmark, the criteria recommend whether the procedure or surgery should be performed in an inpatient or outpatient setting. They also indicate whether appropriate, less-invasive interventions have been attempted prior to a surgical or more invasive procedure. Length-of-stay data is provided as benchmarks for select procedures.

Imaging

The Imaging module covers more than 200 unique imaging tests organized into more than 30 test families, including a full spectrum of high-volume, high-cost tests. Cases in which the evidence does not fully support a specific test and therefore may require a secondary review are identified, as are cases where alternative studies are appropriate based on medical evidence and the specific clinical scenario.

<p>Durable Medical Equipment</p>	<p>The Durable Medical Equipment module supports the medical necessity documentation required for authorization of more than 450 pieces of equipment and accessories. The criteria address commercial adult and pediatric populations. Equipment is presented in a hierarchy of cost and complexity, and guidance is provided within a single review workflow for accessories often included with high-volume equipment.</p>
<p>Molecular Diagnostics</p>	<p>The Molecular Diagnostics module provides criteria that cover more than 800 molecular and genetic diagnostic tests organized into more than 130 test families. Newly developed and complex diagnostic tests and test panels also are presented. The criteria include guidance for lower-cost, nonmolecular tests that may be clinically appropriate. Clinical Evidence Summaries provide extensive support.</p>
<p>Specialty Rx Oncology</p>	<p>The Specialty Rx Oncology module helps guide the appropriate use of oncology drugs for both on-label and off-label indications. The criteria includes evidence-supported regimens that indicate when it is appropriate to give a drug in combination with one or more additional medications. Significantly, the Specialty Rx Oncology module is an automated source for National Comprehensive Cancer Network® (NCCN®) recommendations on appropriate use of off-label prescription drugs and biologics in patients with cancer.</p>
<p>Specialty Rx Non-Oncology</p>	<p>The Specialty Rx Non-Oncology module helps guide the appropriate use of non-oncology drugs, providing clear guidance on step therapy and addressing both on-label and off-label indications. The criteria cover more than 140 drugs for many common conditions. These criteria are updated at a minimum of twice annually.</p>
<p>Specialty Referral</p>	<p>The Specialty Referral module provides information on which type of specialist should be consulted and includes objective clinical criteria for interventions that should be completed prior to specialist engagement. In addition to specialist type, guidance is available on typical duration and sequencing of involvement for the more than 160 conditions or disorders.</p>
<p>Retrospective Monitoring</p>	<p>The Retrospective Monitoring module supports retrospective assessments of more than 260 surgical and nonsurgical invasive procedures to identify opportunities for care delivery improvement. Robust reporting helps determine if procedures were medically appropriate and if correct interventions were conducted prior to the surgery or procedure. When problems are identified, the module helps organizations determine if the issue was an isolated event or part of a larger pattern.</p>
